CHILD SUPPORT

It's hard to believe summer is more than halfway over. Why is it summer always goes by so fast, but winter feels like an eternity? The fact that we live in Ohio and winter does go on forever may have something to do with that. Also, when you look forward to something it seems to go by faster.

This summer we in Child Support are anxiously anticipating extra visitors in July. Every three years we are supposed to get a visit from the State Office of Child Support to make sure we are in compliance with certain confidentiality rules. This is because we deal with specific information involving the Department of Treasury. (I swear I will not break out into a compilation of the Hamilton soundtrack....hopefully.) Our visit is a few years overdue. Thanks, Covid. We've been hard at work getting ready for this visit. There's been a lot of policy to review and write, and our own inspections to make sure everything is in line with regulations. We feel like we're in good shape but wish us luck anyway!

While the State visit is only supposed to happen every three years, one thing we count on every summer is Child Support Awareness Month. This happens each August and there are different events throughout the month. One such event is Wear Green, which will be on August 2nd and is exactly what it says—everyone is encouraged to wear the color green that day. It's not a dress down day, but you are all welcome to participate and show your support for CSEA. On August 10th, the CSEA staff is having an appreciation lunch catered by Ole Zim's. In conjunction with this, we are doing a Federal Tax Information training and Sharon Ochs is going to help us make jewelry as a fun team building project.

For our clients, we are once again offering the license amnesty program during the whole month of August. That means the requirements for reinstating a license will be reduced for obligors (person who pays support). Some of you may not be aware but CSEA has the authority to suspend a driver's license and any recreational or professional license for non-compliance with a child support order. The reinstatement requirements are set forth by the State of Ohio, but in August, we can make it easier to get that license back. Obligor can check with a caseworker on how to do that.

We hope to see you all in green on August 2nd, showing your love for child support workers across Ohio!

Out-of-the-Box Visitation

PCSA Unit has been creating more structured and fun visitations for families here at the agency. Linda Ackerman has worked tirelessly with her brand-new staff to set visitation hours with being “Closed” on Fridays. We currently are hosting about 20 family visits a week at the agency which vary in length of hours and takes LOTS of coordination! We are also providing transportation for our children in custody more than we have in the past. Therefore, you have seen many more children in the halls along with more parents in and out of the agency. We truly do try to be mindful of the noise, but it is not always possible with so much going on and multiple visits at the same times.

Our agency is once again paving the way to new endeavors by having group family visitations at the agency and out in the community. Linda and her team partnered with Share and Care while they hosted an ice cream social at the park. The families’ are scheduled to go to Pottery Perfection in July. One worker is assigned to each family and currently there are about 5 families participating in the group visitations. At the agency, we have provided meals and activities such as crafts, make your own pizza Lunchable (facilitated by our very own intern, Lillie), and fun with the water table. HYPE managed the TANF Summer Youth Employment Program, which assists eligible youth in getting summer employment. This program helps local employers bring in extra summer help without the cost of an additional employee and the youth gains work experience and basic skills for successful employment!

While many assistance programs are returning to normal, pre-pandemic operations, people are no longer receiving as much assistance compared to the last few years. The HYPE program provided supportive service baskets to participants. This basket included items from laundry soap, hygiene products and cleaning supplies; all items that cannot be purchase with SNAP. Our youth have been very grateful and appreciative of this effort!

Finally...did you know staff in the OMJ assisted approximately 238 customers per month in the OMJ Center this month? Assistance is anything from simple job application assistance, help with applying for Unemployment Benefits to scheduled appointments for those receiving services.

We have 1 home study pending with some additional possible transfers from other counties!

Our very own Melanie Allen and Angela Wheeler went to Arizona to become the most recent to be trained in Pressley Ridge pre-service curriculum. We now have 4 certified in this agency to train foster parents in this trauma informed, evidence-based program.

The agency became a member of FFTA (Family Focused Treatment Association) and has 5 staff members attending the FFTA Conference in Columbus from July 10 through July 13.

With summer upon us, staff are more and more involved in fun events around the tri-county collaborative! Many of our events are completed with our CCRC (Child Care Resource Center) partners! 

Public Assistance

Teamwork makes the dreams work! The Public Assistance Unit is partnering with the Sandusky County Jail and Firelands Counseling and Recovery Services to provide Vivitrol shots to inmates incarcerated for drug/alcohol related offenses. Eligibility workers will be interviewing inmates to assist them in obtaining Medicaid for the cost of these shots to be covered. The goal is to alleviate overdoses in the community and help inmates be successful in their treatment programs.

With the Public Health Emergency now over, the emergency SNAP allotments have also ended. This has caused a huge impact on our community. Thanks to all who contributed to our recent food drive. We would also like to thank GLCAP for the continued contributions to the collection. We were able to provide food to local food pantries and allowed several community members to shop for food on site.

Recent power outages resulted in SNAP recipients requesting replacement SNAPS for the cost of spoiled food purchased with SNAPS. - If you are a SNAP recipient and your household has experienced a misfortune (such as a fire or flood, or a power outage lasting more than four hours) that results in a loss of food, you may be eligible for SNAP replacement benefits. You must have received SNAP benefits during the month of the disaster and the replacement amount cannot exceed one month's allotment. Applications for replacement SNAPS must be received within ten days of the outage.

The caseworkers are continuing with [the Medicaid Unwinding](#). That means they are once again conducting annual Medicaid eligibility reviews and terminating coverage for those who are no longer eligible. Annual reviews have not been conducted on anyone enrolled in Medicaid as of March 18, 2020. If recipients failed to report job change(s) or a new address, for instance, more paperwork is required to bring things up to speed.

PRC School Supplies Program

School's out for summer, but not for the PRC unit! While the kids are enjoying the summer off, Chastity Minor and Paula Olds are busily sorting through dozens of boxes of school supplies to build backpacks filled with everything kids will need to start off their school year right in the fall! 




Did you know that I am able to reset your SETS password. Or you can always call the State at 1-800-686-1580, Option 1.

The state keeps updating our system weekly. It usually does this overnight on the network, so if you work remotely on a regular basis, you may have to check your Software Center on a regular basis for any updates you might have missed. While connected to the State network, open the Software Center icon on your desktop or under Start.
