October is Cyber Security Awareness month which is why the State feels it is the perfect month to do our Security Awareness Training. They seem to change it a little each year for the better. We have until the end of October to complete the 4 modules. The links to the modules in the email are not always working, but if you follow the guide on completing the training, that works. Eventually, I will be able to get reports of everyone in our agency who has completed, started or hasn't started the training.

The state keeps updating our system weekly. It usually does this overnight on the network, so if you work remotely on a regular basis, you may have to check your Software Center on a regular basis for any updates you might have missed. While connected to the State network, open the Software Center icon on your desktop or under Start.

And if you ever click reset at the Jabber sign in screen, you will then need to successfully sign in with your Jabber <u>#@ngtsohio.com</u>.

Every once in a while, our phones update just like computers. Sometimes you need to restart your phone for DUO to send notifications.

Soon Taylor and I and Casey are going to meet with a new team at the state who are in charge of IT assessments. This is a new branch at the State's IT department. They are trying to help county's be secure.

## **PUBLIC ASSISTANCE**

#### DID YOU KNOW OCTOBER IS PUBLIC ASSISTANCE WORKER APPRECIATION MONTH ?!

We can't say thank you enough to our workers for all the work they do. The end of the Public Health Emergency has taken a toll on our community and our unit has seen the repercussions. The workers have worked endless hours approving benefits and being the sounding board for the community who are severely struggling. Our unit would not be as successful without them and they truly deserve more than just a month to show our appreciation.

Our county has met the 90% completion rate for Medicaid Renewals for several months in a row now. This goal has been set for all counties in Ohio. A lot of hard work has gone into ensuring this happens and we are all very proud of our workers for their continued effort in meeting this goal as it is quite the accomplishment.

Next is a reminder that we have items for Domestic Violence Victims in our file room. Please contact Kelly Beeker if you find someone in that position who could use some personal care items. We are always looking for donations too. You can also contact Angela Wheeler in Children Services or Trisha Foos in OMJ as well.

With the resignation of Yolanda Santoya we want to send a huge welcome to Leah Doering. We are confident she will be a great addition to our division!

Finally, within the PRC world, 132 backpacks full of school supplies were handed out this year. In addition, they approved over \$95,000 in services ranging from Rental Assistance to car repairs and furniture for families in need.

## **CHILD SUPPORT**

Approved by our fearless leader (thanks, Melanie!), Jackie Mowry is coming up with games, crafts and other fun stuff during our lunch to show how much we appreciate each other's efforts during a time when we need everyone stepping up.

Speaking of stepping up, we have a few CSEA staff members who are doing just that on a bigger scale. Some of us are on Ohio CSEA Directors' Association committees to help direct things going on around the State and will be participating in sessions during the OCDA Fall Conference at the end of October. Cassandra Walter will be part of a panel during a roundtable discussion on Common Child Support Myths & Customer Service. She and Charmin Hetrick are also presenting on our Seek Work Court and Diversion programs in the Alternatives to Incarceration session, which will be moderated by Krista Hovis. Krista will be moderating other sessions, as well as helping with registration and additional tasks. They are also to supply photos to OCSA to be shown in a slideshow during the opening session: "The Child Support Eras Tour". At the end of the quarter, there are officially 7 licensed Treatment Foster Homes; 6 homes have full time placements. We have 2 home studies pending that will be treatment homes, one will focus on working with teen boys! Did you know that Jenni meets with these families a minimum of every other week and completes Treatment plans for each treatment child residing in the home?

In July, the agency sent multiple staff to the FFTA (Family Focused Treatment Association) Conference in Columbus, where they learned new information about retention and hope to implement this with the increasing amount of Treatment Foster homes!

These warmer months had so many events keeping staff busy that we forgot to take pictures!! Events included: Sandusky, Seneca, and Wyandot County Fairs, Upper Sandusky Open Houses at the Elementary and Middle Schools, ProMedica Family Fest, and Max's Miles in Tiffin.

With the assistance of CCRC (Child Care Resource Center), the agency completed it's first Foster Parent Café this quarter. It was exceptionally well attended with 19 adults and 14 children. A HUGE shout out to all the additional staff helping with this event as we totally didn't expect it to go over so well!
